MARKEL VETERINARY HOSPITAL IS A FULL-SERVICE FACILITY PROVIDING HIGH-QUALITY CARE AT LOW COST FOR PETS OF INCOME-QUALIFIED FAMILIES IN THE GREATER RICHMOND REGION AS WELL AS PETS IN THE CARE OF LOCAL GOVERNMENT SHELTERS. OUR HOSPITAL ENSURES FAMILIES OF ALL MEANS HAVE ACCESS TO TREATMENT OPTIONS THEY CAN AFFORD FOR THEIR ANIMAL COMPANIONS. AS AN EXPANSION OF THE RICHMOND SPCA'S PET-RETENTION SERVICES, OUR SUSAN M. THE OVERWHELMING MAJORITY OF PETS WE BROUGHT INTO OUR CARE WERE ONES WE TRANSFERRED FROM GOVERNMENT SHELTERS WHERE THOSE PETS' LIVES WERE AT RISK. IN TOTAL, WE PARTNERED WITH 55 SHELTERS LAST YEAR TO BRING VULNERABLE PETS INTO OUR CARE. MORE THAN 3,250 HOMELESS PETS IN OUR HUMANE CENTER REQUIRED CRUCIAL VETERINARY TREATMENT, WHICH OUR PROFESSIONAL MEDICAL STAFF DELIVERED, FOR A VARIETY OF SERIOUS ILLNESSES AND INJURIES PRIOR TO ADOPTION TO LASTING HOMES IN OUR COMMUNITY.
